

### THE AUSTRIAN CONFISCATION REGIME





#### Confiscation ("Konfiskation", sec 19a ACC)

- □ legal nature: penalty
- any item used or intended to be used in the commission of an intentional offence (instrumentalities; e.g. phone, burglary tools)
- □ any item yielded from such an offence (products; e.g. forged documents)
- $\Box$  replacement value of these items (e.g. sales proceeds)
- prerequisite: sole ownership of the perpetrator at the time of the judgment at first instance
- □ exception: confiscation is disproportionate

- Forfeiture ("Verfall", sec 20 ACC)
  - Extended forfeiture ("erweiterter Verfall", sec 20b ACC)



### CONFISCATION



#### Confiscation ("Konfiskation", sec 19a ACC)

#### Seizure ("Einziehung", sec 26 ACC)

- □ legal nature: preventive measure
- any item used or intended to be used in the commission of an offence (e.g. weapons)
- $\Box$  any item yielded from an offence (e.g. fake money)
- prerequisite: the specific nature of the item deems the seizure necessary in order to combat the commission of offences


#### $\Box$ exceptions

- an authorized person removes or renders useless the specific properties or nature which facilitate the commission of offences
- any items that are subject to legal claims by persons not involved in the offence may only be seized if the person concerned cannot ensure that the item will not be used for the commission of offences


#### Forfeiture ("Verfall", sec 20 ACC)

- legal nature: sanction sui generis (disputed)
- any assets acquired for or through an offence (loot, wages)
  - not permissible if the person who purchased these assets was unaware of the offence (sec 20a (2) ACC)
- □ any benefits + replacement value of these assets
  - not permissible to the extent that the person who acquired these assets was unaware of the offence (sec 20a (1) ACC)
  - monetary equivalent of these assets (value forfeiture)
    - not permissible to the extent that the person who acquired these assets was unaware of the offence (sec 20a (1) ACC)
  - discretion to determine the extent of asset forfeiture
- □ exception: forfeiture is disproportionate

- legal nature: sanction sui generis
- □ three types of extended forfeiture
  - criminal organizations, terrorist associations, terrorist financing (sec 20b (1) ACC)
    - assets in the possession of the criminal organization or the terrorist association
    - assets provided or collected for the financing of terrorism
    - not permissible if the assets are the subject of legal claims by persons who are not associated with criminal organizations, terrorist associations, or the financing of terrorism

#### I Extended forfeiture ("erweiterter Verfall", sec 20b ACC)

- □ three types of extended forfeiture
- criminal organizations, terrorist associations, terrorist financing (sec 20b (1) ACC)
- $\Box$  temporal connection to a criminal offence (sec 20b (2) ACC)
  - commission of
    - an unlawful not necessary culpable act pursuant to sec 278 (founding of or participation in a criminal association) or 278c ACC (terrorist conduct) or
    - an intentional offence punishable with more than three years imprisonment extended confiscation in rem (sec 20b (2a) ACC)
  - assets were acquired for or through these offences
  - forfeiture of any assets obtained in a temporal connection with the offence if there is reason to assume that they were acquired from an offence
  - the lawful acquisition of the assets cannot be substantiated
- $\Box$  extended confiscation in rem (sec 20b (2a) ACC)


- □ three types of extended forfeiture
- criminal organizations, terrorist associations, terrorist financing (sec 20b (1) ACC)
- □ temporal connection to a criminal offence (sec 20b (2) ACC)
- □ extended confiscation in rem (sec 20b (2a) ACC)
  - assets originating from a criminal offence which were secured or seized during criminal proceedings for particular offences
  - not possible to prosecute or convict the person concerned for the crime
  - initial suspicion of the offence is sufficient
  - unexplained wealth model of extended forfeiture
