



ARO Statistics 2023

- 1617 ARO requests
 - 441 incoming requests (mainly from the Netherlands, Czech Republic, Romania)
 - 1176 outgoing requests (mainly to Spain, Belgium, Lithuania)
- 917 of the 1627 requests were in connection with the directive (EU) 2019/1153
